Ballabgarh, Ballabgarh, the following terms and conditions.

TERMS AND CONDITIONS :

1. The school follow the course of study as per syllabus prescribed by the affiliated board.
2. The school shall charge fee and funds as declared to the appropriate authority at the time of application for the recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of change in the fee structure the school shall inform printed receipt of fees/funds to the students.
3. Salary shall be paid as per declaration at the time of seeking recognition.
4. No capitation fee and other charges shall be charged from the children's / parents.
5. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.
6. Managing committee shall not allow to run two schools affiliated by different board / council in the same premises.
7. Managing Committee shall not close down the school or an existing class during the academic session without the prior approval of the appropriate authority.
8. The school shall be open for inspection for the inspection officer authorized by the Appropriate Authority.
9. Recognition so grater shall be reviewed after every 10 years.
10. No financial assistance shall be granted by the Department of the school.
11. School premises shall not be used for commercial purpose and anti National activities.
12. Approval of Managing Committee shall be obtain from the appropriate authority in case of any change in the committee.
13. The Managing Committee shall follow the instruction issued by Government / Deptt. from time to time and supply the information to the Govt. / Department as required.
14. In addition to the above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case violation of any provision of the rules.
15. School will get eqrthquake certificate from competent authority.
16. School will provide ventilated specious as per architectural norms approved by Competent authority.




